## PLANNER (Time-Durated)

Our Planning Division of the Development Services Department is seeking a dynamic Planner to join our multi-disciplinary team on a temporary basis. As a mid-level professional Planner, you are engaged in a variety of planning functions where you will apply your sound knowledge of planning theory in both the development and policy planning disciplines.

You will be responsible to coordinate and process a range of development applications including development permits, land use amendments, and subdivisions; liaise with municipal and other government agencies; provide information and respond to queries from internal and external sources; prepare reports for Council with recommendations; research, analyze, prepare and conduct intermediate planning studies and research projects; develop projections and plans for industrial, commercial, residential and other areas of land use.

In addition to a bachelor's degree in geography, community planning, or related field supplemented by urban/community planning courses and two years' experience in municipal planning, the ideal candidate will have excellent writing and communication skills, and will work well with elected officials, the development community, and the public. We are seeking an individual with a willingness to learn more and a desire to work in a dynamic, deadline driven team environment. A strong knowledge of the Local Government Act, Land Title Act and the Community Charter as they relate to local development is required; membership in CIP is preferred.
