BYLAW 1706-1987

A bylaw to prohibit the sale, use and possession of firecrackers
and other fireworks of every nature and kind

WHEREAS it is provided by Section 932(e) of the "Municipal Act", that the Council may by bylaw regulate or prohibit the sale or disposal of any person of firecrackers and other fireworks of every nature or kind:

AND WHEREAS it is provided by Section 933(a) of the said "Municipal Act" that the Council may, by bylaw, applicable throughout the Municipality regulate or prohibit, inter alia, the exploding of firecrackers or other fireworks;

AND WHEREAS it is provided by Section 933(1)(a) of the said "Municipal Act" that the Council may, inter alia, authorize the issuance of a permit to any person or organization for the use of firecrackers or other fireworks of any nature or kind and may specify the terms and conditions thereof;

NOW THEREFORE the Council of the District of Mission, in open meeting assembled, ENACTS AS FOLLOWS:

1. This Bylaw may be cited for all purposes as "District of Mission Fireworks Bylaw No. 1706-1987".
2. The sale of firecrackers and other fireworks of every nature or kind is hereby prohibited in the District of Mission.
3. The throwing, propelling, ejecting, lighting, firing, exploding, setting off, discharging or possession of firecrackers or other fireworks of every nature or kind is hereby prohibited in the District of Mission.
4. Notwithstanding the provisions of Section 3, a Special Permit for the exploding of firecrackers and other fireworks of every nature or kind may be issued by the Clerk to an organization, upon application.
5. For the purposes of this bylaw, "organization" shall mean an incorporated association, company, society or other incorporated body.
6. Each organization requesting the issuance of a Special Permit, in accordance with the provisions of Section 4, shall provide the name of a person representing the organization, who shall be known as the Fireworks Supervisor. The Fireworks Supervisor shall possess a valid Fireworks Supervisor Ticket, issued by the Explosives Branch of Energy, Mines and Resources Canada.
7. Every person or organization contravening or committing any breach of, or committing any offence or infraction against any of the provisions of this Bylaw, shall be liable, on summary conviction before any Court having jurisdiction, to a fine of not more than One Thousand (\$1,000.00) dollars.
8. "District of Mission Fireworks Bylaw No. 382-1974" is hereby repealed.
