Amy Seabrooke, Consultant, Stantec Re: Community Energy and Emissions Plan

Amy Seabrooke, consultant and project manager with Stantec, appeared before Council to present the draft Community Energy and Emissions Plan (CEEP).

Ms. Seabrooke provided the following overview:

- there are several reasons for Mission to take action with a Community Energy and Emissions Plan:
 - Provincial legislation that asks municipalities to set greenhouse gas (GHG) reduction targets and adopt them into their official community plans,
 - public opinion and concerns about climate change, and
 - numerous other benefits for Mission such as local jobs, affordable housing, walkable neighbourhoods, a vibrant downtown and energy resiliency;
- the process began in the spring with a project launch, brochure and press release, and a community survey both online and in hard copy;
- there were 170 responses to the survey which is considered to be a good turnout;
- 72% of respondents said they “completely” support the District of Mission in taking action to reduce energy use and GHGs;
- a task force was formed of key stakeholders who attended three half-day workshops, performed research and analysis, and developed energy mapping and reduction scenarios;
- the Province provided a base line measurement in 2007 that showed personal vehicle use accounted for 32% of energy consumed and 49% of GHG emissions;
- the District of Mission has adopted the following GHG emissions reduction targets in its Official Community Plan (OCP): 20% below 2007 levels by December 31, 2020, and 80% below 2007 levels by December 31, 2050;
- the main goals of the CEEP are to:
 - develop a complete community where residents can live, work and play,
 - encourage low-carbon mobility,
 - increase the energy efficiency of existing homes,
 - ensure new homes achieve high standards of energy efficiency,
 - advance implementation of research and development opportunities for alternative and district energy systems,
 - develop local economic opportunities and where possible, focus on the green economy, and
 - promote the 6R’s of waste management (rethink, reduce, reuse, recycle, recover, and residual management);
- the next steps in the process are to solicit feedback from the community on the draft CEEP, to raise awareness for implementation through various planned events in late November/early December, and to bring the final CEEP back before Council for endorsement.

Council noted that realistic targets need to be set and feedback given to the Province.


