4. NEW BUSINESS

(a) Updated Terms of Reference

The updated Terms of Reference, as approved by Council on April 15, 2024, was provided to the Committee.

Discussion was held on whether there is adequate citizen representation within the membership and if an additional position should be added to represent the housing sector (such as developer, bank representative, mortgage broker) who would provide perspective from the profit/financial side of the community.

(b) Election: Chair and Alternate Chair

D. Hein was appointed Chair by acclamation. The position of Alternate Chair not appointed and will be brought forward at the next meeting.

(c) Official Community Plan (OCP) Update

M. Dickinson provided an update to the Committee on the progress of the OCP Update and informed the members on the upcoming open houses and pop-up events for the public to be held June 18 & 19 at various locations in Mission: Leisure Centre, Albert McMahon School, Mission Central School, Mission Central School, and Library.

As well, a World Café will be held on June 19 with various committees and community groups invited to attend. This event will be held at the Leisure Centre from 10am until noon.

The members were informed the rural communities will be consulted during the next round of public consultation for the OCP review.

Action Item: M. Dickinson to inform the FVRD Board members of the upcoming public consultations and to also include the youth in Mission.

(d) Provincial Housing Legislation

M. Dickinson provided an update on Mission's progress towards implementing the new provincial housing legislation and informed:

- Mission is working toward having the Zoning Bylaw amended and updated by July 2024 to comply with the Small Scale Multi Unit Housing (SSMUH) legislation;
- The Transit Oriented Area (TOA) legislation allows for no parking for residential units. The legislation only requires parking for commercial and handicap units. The proposed bylaw to implement the TOA was presented to Council however the bylaw was deferred for further changes; and,
- Mission has been identified by the Province as not meeting the required housing targets.

(e) Affordable Housing Strategy Implementation

Dena Kae Beno, Housing Coordinator, provided updates to the Committee on the *Affordable Housing Lunch Series* with the final session held in July at the Copper Hall.

As well, the Committee was updated on the *Affordable Housing Innovation Day* to be held on June 27.
