I am aware that skateboarding, scootering and BMX riding, involves many risks, dangers and hazards including but not limited to: boarding, entering and exiting the event area; collision or contact with other riders; or other users of the area; collision or contact with any of the infrastructures within the area, including but not limited to piping, conduits, sprinkler heads, light fixtures, walls, ceilings, floors and any and all appurtenances and attachments.

I warrant that I am physically fit and capable of participating in this Event without undue risk.

I AM AWARE OF THE RISKS, DANGERS, AND HAZARDS ASSOCIATED WITH SKATEBOARDING, SCOOTERING, and BMX RIDING AND I FREELY ACCEPT AND FULLY ASSUME ALL SUCH RISKS, DANGERS, AND HAZARDS AND THE POSSIBILITY OF PERSONAL INJURY, DEATH, PROPERTY DAMAGE AND LOSS RESULTING THEREFROM.

I HAVE READ AND UNDERSTOOD THIS AGREEMENT AND I AM AWARE THAT BY SIGNING THIS AGREEMENT I AM WAIVING CERTAIN LEGAL RIGHTS WHICH I OR MY HEIRS, NEXT OF KIN, EXECUTORS, ADMINISTRATORS, ASSIGNS AND REPRESENTATIVES MAY HAVE AGAINST THE RELEASES.
